# 2024 ANNUAL MEMBERSHIP MEETING

# **MINUTES**

May 21, 2024 6 pm Sonrise Church Olympia, WA

#### Call to Order:

- President Billie Stuart called the 2024 Annual Membership Meeting of the Thurston County United States Bowling Congress Association (TCUSBCA) to order at 6:01 pm.
- Vice President Eric Rose began the meeting leading everyone in the Pledge of Allegiance.

# Roll Call:

 One (2) TCUSBC Officers, Three (3) TCUSBC Directors, and Twelve (12) TCUSBC Members for a total of Seventeen (17) present.

# Approval of Minutes:

 The minutes from the May 30, 2023 Annual Membership Meeting were distributed to members as they arrived. Eric Rose made a motion to accept the minutes as written, seconded by Deb Webb- motion approved.

# **President's Report:**

 Billie welcomed everyone to the meeting and thanked them for attending. She has nothing additional to report.

# Association Manager Report & Acts of the Board:

- This season we had 1,232 adult members and 63 youth members. We are 56 adult members up from last season, but down 7 youth members.
- All the tournaments from last season returned this year. The Board added \$300 guaranteed first place prize to each of the adult championship tournaments.
- Brooke attended National USBC Convention for the second year and was awarded
  the Youth Delegate Grant which paid for her trip and gave her a unique experience
  different from the previous year. She was able to network with other young USBC
  Delegates and learned a lot from them on how they navigate the age differences in
  their communities.
- She also attended the Washington State USBC, where she was appointed to serve
  the board as a West Side Director. She is excited to learn during her term and find
  new ways to shape the organization.
- Brooke expressed her gratitude to the board for their support through the season and is looking forward to next season.

# **Committee Reports:**

#### Finance Committee:

- Deb Webb reviewed the budget report shared in the meeting packet. The Association budget is on track.
- There will be an audit done in July and it is expected to go well.
- There was an additional \$800 expense for the State convention, but we are still under budget for the season.

# Youth Committee:

• Kelly Gage shared there was positive turnout and feedback at the youth tournaments this year.

# **Tournament Committee:**

- Brooke shared results of the tournaments held this season:
  - o Youth:
    - Adult/Junior tournament held at Westside Lanes had 29 teams.
    - Youth Championship tournament held at Westside Lanes with 3 teams, 9 doubles, 12 singles, and 7 all events participants. As with membership, attendance was down from last year. (Last year: 5 teams, 12 doubles, 33 singles, 13 all events).
  - o Open:
    - Open Championship Tournament was held at Aztec Lanes with 22 teams, 46 doubles, 78 singles, and 64 all events participants. This was a significant increase from last year (16 teams, 26 doubles, 45 singles, 12 all events handicap and 11 all events scratch).
  - o Women's
    - Scotch Doubles event held at Aztec Lanes was very fun.
    - 23 teams participated; this was triple the amount from last year (7 teams).
  - o Trios:
    - Trios tournament was held at Westside Lanes with 39 teams participating. This is double last year's participation (19 teams).

# **Charities Committee:**

- Eric shared that Bingo for the Cure was held in March at the VFW Hall with 20 games of Bingo for \$20 and a silent auction.
  - \$4,704 donation was made to Fred Hutch because of the great turnout and success of the silent auction.
  - The board is asking members to help promote this event and if there are any businesses that you might have contacts for please direct them to Eric Rose.

# **Awards & Recognition Committee**

Billie Stuart and Kelly Gage distributed Scholarship awards to these youth bowlers:
 Kiarra Blume, Jeremiah Clark, Andrew Scheibe, and Jase Cassou.

# **Legislative Committee**

- USBC Annual Meeting Report was distributed in the meeting packet.
  - Held April 22-26,2024 in Las Vegas at Southpoint with the theme "Experience is Everything"
  - There was a focus on increasing the experience of our events and improving them.
  - Deb enjoyed a session on how to communicate across different generations.
     She learned a lot.
  - Brooke was selected to participate in the Young Delegate program and connected with young people as directors and association managers. She was the youngest and the next closest was 27 years old. There were 14 young delegates in the program.
  - There was originally one proposed amendment, but it was withdrawn so no voting was required.
- WSUSBC Jamboree Report was distributed in the meeting packet.
  - 2024 WSUSBC Jamboree was held in Richland, WA on May 4-5, 2024 at the Best Western.
  - The meeting began with a video from the 2017 USBC Convention titled "Laugh at Fear"
  - There was a presentation by the developer of Tournamentbowl.com explaining how it can help us with our tournaments. The USBC national Tournament has an online registration program that is available to local associations that can be imported to WinLabs.
  - Seven Scholarships of \$2000 each were awarded.
  - Brooke Johnson has been appointed to the State Board to fill a vacated Director Position.

**Nomination Committee:** There is one (1) President, two (2) Director positions, three (3) State Delegates, and three (3) National Delegates up for election this year. A ballot packet was distributed to eligible members.

- President- application received from Billie Stuart, current Vice President
- Directors: applications received from current director Connie Gent and Chad Bachman.
- State Delegate: application received Deb Webb
- National Delegate: applications received from Brooke Johnson and Deb Webb.
- All positions are running unopposed-
  - Dwayne Webb made a motion to accept Billie Stuart as President by acclimation, Deb Webb seconded. Motion passed unanimously.
  - Dwayne Webb made a motion to accept Connie Gent and Chad Bachman as directors by acclimation, Eric Rose Seconded. Motion passed unanimously.
  - Dwayne Webb made a motion to accept Deb as State Delegate and Brooke and Deb as National Delegates by acclimation, Eric Rose seconded. Motion passed unanimously

#### **New Business:**

- Group Discussion: suggestions on how to get more participation and attendance at the annual meeting.
  - Magnets were distributed this year with all event dates including tournaments and the annual meeting. Some secretaries didn't get them or did not distribute them to members.
  - Members all agree an online presence/website is needed. Facebook and Mailchimp email blasts are not enough.
    - Website content should include:
      - leagues looking for players
      - league rules and secretary contact information
      - Calendar of Events
      - Board biographies and contact information
  - Fliers larger than 8.5X11 could be distributed to the houses and shared by league secretaries via email. They should include a QR code for the website.
  - Texting can be difficult to manage, and the Association would have to purchase a program and get permission from members. "Remind" is what North Thurston High School uses for text/email notifications of events/meetings.
  - Lane/House representatives don't really participate in the Association; one is a house owner and one is an employee. Association members should contact board members directly instead with any suggestions or concerns.
- Group Discussion: How do we build up our youth programs?
  - Contact parent organizations at local schools- PTA/PTO to share bowling program benefits and leverage newsletters/contacts. Volunteers are needed to make this happen.
  - Post Road Signs for bowling leagues (like election signs) near schools and community locations focused on youth events and programs.
  - o Aztec lanes hands out postcards for Kids Bowl Free and their youth program.
- Scholarship Program- We could build up our scholarship program by changing it to allow recurring applications (not just high school seniors but college students still attending) or create a second program for adults in school.
- String Pins- data is being collected on averages to develop a conversion.
  - The difference in averages to non-string pins is so negligible that the nonstring average can be used in the national event.
  - Next season WSUSBC will be hosted by Oakbowl and run string pins in the Open and Women's events.
  - There are varying opinions on string pins. The cost to houses to maintain string pins is lower than freefall.

# **Legislative Committee Report - 2025**

The 2025 convention was held in Las Vegas at Southpoint from May 5 – May 8, 2025. The theme this year was "Share the Vision".

Our week began with Jim Morris as the keynote speaker with a focus on you can achieve your dream if you have enough determination. His life story was made into the heartwarming an unforgettable Disney Movie, The Rookie. It ran true with many of that if you just stick with it you can accomplish many things.

The convention consisted of very several informative seminars. The subject presented were; Powerful Listening, Act like a Super Hero, Leading Board Meetings in 90 minutes or less, Annual Meeting and Hall of Fame Best Practices, Hosting a New Bowler Clinic, Raising your Leadership Lid, Tech Tools for Success: Envisioning More Efficient Associations and the ever-popular Rules Quiz session.

Your delegates, Brooke Johnson, Dwayne Webb and Deb Webb split up to be able to have one of us attend all the sessions. One important thing we learned is that Associations across the country are facing many of the same struggles as Thurston County. Membership is down and many leagues and bowling centers are struggling to survive. We spend a lot of time networking with other board members discussing on how to increase interest in league bowling and how to continue to support our bowlers as we face rising costs and decreased membership.

This year there were 695 Association Delegates, an increase of 42 from 2024, 2 Athlete Delegates, 22 Hall of Famers and 16 Board of Directors present. The legislative session began with the National Youth Award and USBC National Recognition award presentations, followed by the USBC Committees presenting their reports, all of which you can view on bowl.com.

Four Proposed Bylaw Amendments were presented to the members.

- Proposal NB 1 proposed a change to the USBC National Bylaws making the payment of state dues optional. Bylaws Proposal No. NB 1 – Rejected (38 approve, 563 reject)
- Proposal SB 1 proposed a change to USBC State Bylaws removing the ability to reappoint an individual to
  a state board who has been removed due to a lapse in their RVP status. Rejected (38 approve, 553 reject)
- Proposal SB 2 proposed a change to USBC State Bylaws to allow states to host a virtual Annul Meeting.
   Approved (564 approve, 29 reject)
- Proposal LB 1 proposed a change to USBC Local Bylaws that would remove the ability to reappoint an
  individual to a local board who has been removed due to a lapse in their RVP status. Rejected (31
  approve, 563 reject

Five candidates ran for positions on the USBC Board of Directors, which had three open positions. Elected for three-year terms were Chrissie Kent, New York; Natan Shock, Colorado; and Zachary Boulanger, Wisconsin.

Congratulations also are in order to our own Brooke Johnson for being appointed to serve a three-year term on the USBC Youth Advisory Group.

We want to thank the members of Thurston County USBC in trusting us to represent you at our national convention. It was another year of amazing workshops and a great year of achievement on all levels as we work to bring back bowling.

The meeting began at 9:00 on Saturday starting with an activity presented by USBC Jarrod Gallegos. The activity called the Wheel of Life had everyone rating the health of their local organization in several areas. After individually rating each category, the association members gathered together to compare where each felt how the association was doing in each of the categories. It was a great way to start the meeting and get everyone participating early on.

Robert Hanson, from the WSBPAA presented information on how the BPAA works with USBC, and Brooke Johnson gave a presentation on website development and how important a website is to an association. Both were very informative and the delegates enjoyed the presentations.

Thurston County has not raised the local dues since the merger of ABC and WIBC in 2005. Costs have increased substantially since 2005, and additional funds are required to continue to support the bowlers of Thurston County. Thurston County's Association Manager's salary has not been increased since 2019. The association manager is responsible for managing the day-to-day operations of the Association, providing administrative support to the Board, and coordinating services necessary to comply with USBC guidelines and performance standards and Association policies and procedures.

Thurston County USBC has also developed an award program, and is establishing a Hall of Fame program to recognize bowler achievements during the season, as well as life time achievements that cannot be implemented without additional funding.
